## RISK DISCLOSURE STATEMENT

### Scope

In consideration of BullMarkets.com agreeing to engage into trading with the undersigned (hereinafter referred as a “Client”), the Client acknowledges, understands and agrees that:

### Trading is Very Speculative and Risky.

Trading is highly speculative and is suitable only for those Clients who:

- a) understand and are willing to assume the economic, legal and other risks involved,
- b) are financially able to assume the loss of their total investment,
- c) understand and are knowledgeable about trading and the underlying assets.

Trading is an appropriate investment for retirement funds. Client represents, warrants and agrees that Client understands these risks, is willing and able, financially and otherwise, to assume the risks of trading and that the loss of Client’s entire account balance will not change Client’s lifestyle.
